For this part of the platform, we will collect information from your child because judges will interview competitors as part of the event. Video interviews will include video and audio of the competitor, and the interview may include a discussion of the submitted project and other questions posed by the event sponsor and judges.

<u>Uses and Disclosures of Data</u>. We only use information about participants who are under 13 to provide the RocketJudge platform. We do not use their information for any other commercial purpose. Participants who are under 13 cannot make information available to the general public via our platform, and we will only share the information with the event sponsor, judges, and staff. However, the event sponsor may publish the results of a competition.

<u>Third-Party Operators</u>. We use Amazon Chime for video meetings with event participants. Amazon will collect participants' login time and IP address. <u>Parental Rights</u>. We do not require disclosure of more information than is reasonably necessary to participate in the event. In addition, parents may review personal information about their child on the RocketJudge platform, direct us to delete it, and refuse to allow further collection or use of the information. Parents may also restrict certain disclosures of personal information (however, parents cannot for example, restrict disclosures to events which are required as part of our services).
