Application Procedures

1. Read the Program Regulations prior to completing an application for TEACH Grant funds.
2. Undergraduate and Graduate students must submit this application to the Office of Financial Aid.
3. Students must be accepted into an approved TEACH Grant program at Piedmont University prior to submitting this application.
4. In addition to the Application to Participate, students must also submit the Agreement to Serve or Repay and TEACH Counseling (<https://studentaid.gov>) each year. Piedmont University will verify that these are completed prior to disbursing funds.
5. Piedmont University application deadlines for TEACH Grant correspond with the loan deadlines each term. Funds are awarded and disbursed after the term begins; therefore, funds will serve as a reimbursement. If awarding Federal TEACH Grant would cause a student's aid to exceed the cost of attendance, the Office of Financial Aid must, in accordance with federal student aid regulations, reduce the student's other aid, usually student loans.
Note: If you are awarded the Federal TEACH Grant and would like a reduction in your student loans, you must complete an electronic loan adjustment available on the Piedmont website by the deadline.

Federal TEACH Counseling for the 2024-2025 Academic Year:

TEACH Grant Initial and Subsequent Counseling will explain the program and service obligation that must be met as a condition for receiving the Grant. Before completing the annual Agreement to Serve or Repay, applicants must first complete TEACH Grant counseling for each year the grant is received. The Federal TEACH Grant must be repaid through service or cash as required by the U.S. Department of Education. TEACH Grant regulations require that grant funds be converted to an unsubsidized loan, with interest from first term of disbursement, if the recipient does not comply with the service requirements.
